

# INDOCTRINATION MASQUERADING AS EDUCATION

It's no secret that politics has always been a dirty game played by corrupt largely self-serving individuals that no one in their right mind would ever invest a deep level of trust in... But this isn't the biggest threat to freedom and liberty in the United States.

Ground zero for all evil threatening the United States today is EDUCATION, far better defined as *indoctrination masquerading as education*, from K-12 and especially on the college campus.

Education teaches how to think... Indoctrination teaches what to think. Today's education system in the USA has been teaching kids WHAT to think, not to think for themselves, follow the facts, seek truth, discern reality from fantasy. A general lack of these fundamental skills has created at least three generations of young adults who think socialism and communism are two different things and that both are more desirable than freedom and self-determination.

There is no way to "Make America Great Again" without solving this critical cultural problem. Allow me to demonstrate...

## **INDOCTRINATED COURTS**

Appointees to all Federal Courts are American Bar Association members, many of them Poison Ivy League trained, all of them lawyers who have graduated Law School sometime post-1940s. Not only are these appointees "indoctrinated in Law School" into British Common Law theories of "precedence and procedure," rather than Constitutional Law, they are members of an elite club that is committed to the use of British Common Law tactics as a means of empowering the legal system by undermining the Constitution and Bill of Rights.

This is why we watch our courts issue rulings that are glaringly "unconstitutional" on a daily basis. It is why President Trump has had to fight the Federal Courts every step of the way, just to keep his oath of office and promises to the American people. It's why we see Congress and the Courts work against the American people, in favor of criminals, terrorists and illegal aliens. It's why we have innocent people serving time in prison, despite having no evidence presented against them in a court. It's why the courts think they have the power to make laws, amend laws or even amend the US Constitution via broad politically motivated interpretations based in British Common Law.

But... these lawyers and judges are only doing what they were taught to do in Law School. They were taught to ignore the Constitution and Bill of Rights as irrelevant pieces of paper. In fact, they were taught to empower themselves and each other, by doing so. They are only executing the evil they were taught.

## **INDOCTRINATED CONGRESS**

Article I - assigns lawmaking authority to Congress, via a very strict set of lawmaking rules and under very limited lawmaking authority. They are the “lawmaking” branch of the Federal government. But due to the indoctrination they received growing up, in concert with their endless quest for personal power, they act as though that power is entirely unlimited. They reach into the Second and Third branches of government daily in an effort to force their will upon the other allegedly “co-equal” branches.

I say allegedly for this reason... Because duties and authorities are separated entirely among the three branches under Articles I, II and III, the branches are in no way “equal” according to the Constitution. Because Article I assigns all lawmaking authority to Congress, the Executive and Judicial branches are in no way “equal” to Congress in the arena of making laws.

Likewise, Congress has NO authority whatsoever in the arena of Executive branch authority, or Judicial branch authority. The three branches are not “equal” or “co-equal” simply because each branch is assigned entirely different duties and the authority to only carry out those specific duties.

Yet, the indoctrination that has taken place in the USA over the past seventy-years or so, has blurred the lines of critical separation of powers between these three branches today.

### **INDOCTRINATED ECONOMISTS**

Have you ever wondered who drove our country to \$23Trillion in public debt? Right, the expert economists... Clearly, they were never taught to be good stewards of financial assets, which one would think is the basis for any decent course in economics. So, what does their indoctrination look like?

It looks like how any child thinks about economics, until we run out of money, there’s no reason to watch our money closely. They were taught that if you run out of money, you just print more money. If you don’t earn any money, just borrow the money and if you can’t borrow the money, steal it from someone else who does make the money.

How else do you think the “expert economists” drove the most prosperous nation on earth to \$23T in debt? And who do you think is going to fix that, the expert economists?

### **INDOCTRINATED JOURNALISTS**

Similar to Constitutional Law being replaced by British Common Law theories in American Law Schools, journalism courses have also been changed from teaching real journalism to teaching journalistic activism. This is why every “news report” today reads or sounds like a politically motivated OPED.

No longer are journalism majors taught to follow and report the facts. Instead, they are indoctrinated to “make a difference in the world,” – “take a side” – use their position in journalism to alter the thinking and voter demographics of the public at large through propaganda pieces called “news.”

## **INDOCTRINATED VOTERS**
